EWBL PLAYER CODE OF CONDUCT

1. I will treat myself with respect and take responsibility for my actions.
2. I will encourage good sportsmanship by demonstrating positive support for all players, coaches, officials and administrators at every game.
3. I will place the emotional and physical wellbeing of my teammates and opponents ahead of my personal desire to win.
4. I will treat other players, coaches, spectators and officials with respect regardless of race, gender, creed or ability.
5. I will demand a sports environment that is free from drugs, tobacco and alcohol and will refrain from their use at all East Washtenaw Basketball League sporting events.
6. I will not berate the officials or "trash talk" my opponents.
7. I will not use profanity.
8. I will express my concerns through the proper channels in a dignified manner.
9. I will respect all volunteers, staff and administrators that are involved with the conduct of these events.
10. I will take care to ensure that all facilities and equipment are used as they are intended and see that they are returned in as good of shape as they were given.
11. I will work to ensure that my grades and behavior in school are a positive reflection on myself because I understand that academic achievement is far greater than athletic achievement.
12. I will take responsibility for bringing my EWBL membership card to each league event, understanding that failure to do so will result in my inability to play.
