The YMCA Annual Campaign is a yearly fundraising effort that allows us to fully realize our mission, especially as it relates to the last two words: "for all." The Y recognizes the importance of financial accessibility and is determined to make membership and program fees affordable for everyone in our community.

This annual fundraising initiative serves as the backbone of our philanthropic efforts by securing charitable gifts from YMCA members and the community to ensure our programs and services remain accessible. Every donation stays within our Y in the form of financial assistance, program subsidies, and to keep our doors open to all. These funds ensure all community members have access to the Y and advance programs that address community needs.

Membership dues cover the costs of operating YMCA facilities, but they do not support additional costs for outreach programs and financial assistance for the less advantaged. Our Ann Arbor YMCA Annual Campaign raises funds to benefit safe, high quality, character-building programs that serve people of all ages across 32 program sites, including four branches in Washtenaw County and YMCA Camp AGQ in northern Michigan.


